### Introduction

Parcells Middle School continues to provide a productive and safe learning environment for students. Dedicated and caring professional teachers and staff provide instruction and support for students enabling a high level of student achievement as measured by our annual MEAP tests, NWEA tests, and our own annual Grosse Pointe Writing exam. While



we carry on with our school improvement work and planning (see goal section below), Parcells continues to maintain test scores indicating high levels of student achievement. Hundreds of students representing all three grade levels were honored for their academic achievement at our annual Honors programs. We are proud of the work of our teachers and students. We are also proud of the support of the parents of Parcells' students. The general support of parents as well as the specific support and dedication of parent volunteers who give a great amount of volunteer time provide the foundation for a safe and successful Parcells school program.

Parcells' students take part in a variety of extra-curricular athletic and non-athletic activities beyond the core academic program. Parcells' students participated in and won competitions in MathCounts, the Social Studies Olympiad, the Geography Bee, the Spelling Bee, and others. One Parcells student went on to the National Geography Bee competition in Washington DC. A Grosse Pointe team including a Parcells representative competed in the Global Destination Imagination competition in Tennessee. Parcells students participated in the Michigan Mathematics League competition every school year and Parcells' students were recognized for their accomplishments. Our students in instrumental and vocal music programs competed regionally in a Music-in-the-Parks Festival

in Ohio. Our students were rated 'Excellent' or 'Superior'' in each of their events. Particularly, the 7th grade band won the 'Judge's Choice Award' for earning the top score of all middle school bands at the festival and Parcells Middle School won the 'Espirit de Corps Award' over every other school at the festival for their exemplary school spirit and outstanding behavior.

Assignment of Students

The Board has determined attendance areas and students shall be expected to attend school within that area. A parent may request a transfer or appeal a placement decision on behalf of their student.

The principal shall be responsible for assigning students to classes. In the elementary schools, the principal, in determining the grade level for any new student, may take into consideration the previous schooling of the student but may assign the student to a lower grade level or higher grade level, if in the principal's judgment such an assignment would be in the best interests of the student. In the middle school and in the senior high school students will be assigned to counselors, classes and instructors by the building principal.

The district also has in place policies and guidelines which guide promotion and retention.

### **Core Curriculum**

The Grosse Pointe Public School System's core curriculum is developed under the auspices of the Educational Programs Leadership Council (EPLC), a group of teachers, parents, students, and administrators who meet monthly.

The core curriculum is based upon state standards in all subjects and extends beyond those standards by incorporating exemplary national standards. Curriculum committees, comprised of teachers, parents, students and administrators develop plans for each curriculum area. In addition, the views of the broader community are sought through Public Forums. The reports of the curriculum committees, which are submitted first to the EPLC and then to the Board of Education, include recommendations regarding assessment, staff development, integration of technology, and differentiated instruction to accommodate academic diversity as well as the curriculum itself. The district also offers a wide array of advanced placement and challenging enrichment courses and a comprehensive special education program.

During 2009-10 the district began implementation of the new social studies curriculum for grades K-3, and 5-6. Grades 3 and 4 will be rolled out in 2010-11. English/language arts curriculum was the core curriculum under review, roll out is planned for the fall of 2010. Computer education curriculum continues to be under review, these curriculum changes will reflect the district's investment in new curriculum for teachers grades Kindergarten through twelve.

The district's strong curriculum is demonstrated by the continuing high performance of our students on standardized assessments including NWEA, MEAP, ACT, SAT, and Advanced Placement tests.

## **School Improvement Plan**

Parcells School Improvement Goals are:

To increase student scores in Math, Science, Social Studies, and Language Arts as measured by student performance on MEAP, NWEA, and Grosse Pointe Writing assessments.

To improve student achievement in reading and writing literacy, supported by all teachers in all content areas, as measured by MEAP, NWEA, and Grosse Pointe Writing assessments.

To improve the school climate as measured by student, teacher, and parent feedback and observation.
