GPFPE Board members Cat Ruffner and John Danaher presented a \$41,000 grant to the district directed to the FAST Reading program. The next grant deadline is 6/1/09. Forms are on the website under the Community dropdown.

# First Section 99 grant proposal for technology received from North

North High School staff worked with the Technology Department and Lee Warras to bring forth their proposal for technology integration using the Section 99 Lighthouse Grant monies secured by former Representative Gaffney. Proposals from South High School and the middle schools are expected next month, with the elementary proposals to follow that. The grant totals \$1.3 million and is to be used for projects in math, science and technology. The technology proposals are designed to provide equitable minimum standards for classroom technology that will be specific to grade levels and departments.

Board rejects proposal for enrollment of children of nonresident staff In a 5-2 vote, the Board of Education rejected a proposal to allow enrollment of children of full-time, nonresident staff.

### **General Appropriations Act Amendment No. 2 passed**

Because of a decrease in enrollment and a decrease in the revenue from the State Categorical and 20J funding, GAAA #2 was presented to adjust both revenues and expenditures. This also accounted for the increase in funding due to the Section 99 "Gaffney" grant.

# March agenda highlights
