Curricular materials under review

Updated videos for the Human Sexuality portion of our High School Health curriculum will be available for review by board and community members from January 7-January 28, in the curriculum office at 389 St. Clair. These were recommended by the Human Sexuality Advisory board which is comprised of parents, clergy, a community health representative, teachers, and administrators. Also being reviewed is a proposal to revive a course entitled Digital Seminars. That course will examine new and emerging technologies in social and digital media. Students will use digital tools to think critically, collaborate, create and communicate. They will leverage connected learning and sharing to manage their online identities and digital footprints through responsible use of social media and digital applications.

Informational items include residency and budget updates
