IV. AGENDA ACTION ITEMS FOR AUGUST 20, 2012

A. Approval of Contract with EduStaff for Interim North High School Principal

The services of an interim principal for North High School for the 2012-13 school year are needed for the optimal functioning of the school. Dr. Harwood, Dr. Dean, Mr. Johnson and the North Assistant Principals interviewed Mr. Tom Tobe several times and found him to be the best match for this important position. Mr. Tobe is an experienced middle school and high school administrator from the Livonia and Troy School Districts, and most recently, served as the interim principal at Lake Orion High School.

Grosse Pointe Public School's current contract with EduStaff allows them to provide contracted administrative services to the GPPSS at a fee rate of 11.5% of compensation amount (beginning August 21, 2012 through June 30, 2013). The administration recommended that the contract with EduStaff for the services of Mr. Tom Tobe as Interim North High School Principal be approved.

C. Approval of Tuition Rates for Students Found in Violation of State Requirements

At the July 23, 2012 meeting, the Board of Education approved tuition rates (for legal residents as defined by State law) for those students moving in and out of the district and for high school seniors.

According to Board Policy 5111, "...the Board may establish a higher tuition rate for those who are found to have enrolled or remained a student in the District without any right to do so."

In accordance with that language the administration is recommending a tuition rate of \$13,030 be approved by the Board to address those students who have violated State residency laws and District requirements. It is the administration's belief that this higher tuition rate will be an additional deterrent to those parents/guardians thinking about or willing to try to enroll students to circumvent and violate State law and District requirements.

This amount, once approved by the Board, will be included on the enrollment affidavits that are signed and notarized. It will also be included on our web site. This tuition rate and any costs associated with the investigation and removal of a student will be assessed against those who have violated State residency laws.
