## **MEETING MINUTES**

# I. <u>CALL TO ORDER</u>

Mrs. Zaylor explained to candidates the 2 minute limit on answers and the need to watch the time keeper so as to be able to finish a comment. There will also be 2 minute opening and closing statements for each candidate.
