MEETING MINUTES

I. <u>CALL TO ORDER</u>

President Gafa called the meeting to order at 7:00 p.m.

III. <u>SUPERINTENDENT'S REPORT</u>

A. 2015 Summer Learning Program Report

The 2015 Summer Learning Program administrators were introduced by Mrs. Bur. Nancy Reith shared information about the ELL Program which kept 17 students engaged in reading, writing and speaking over the summer. Donna VanJaarsveld shared the progress of the 60 students that qualified for summer services with a focus on the five senses of summer theme. Geoffrey Young was the Director of secondary summer programs noting the attendance of 250 students; some to improve grades and obtain enrichment, some to recovery learning in a subject not passed and others to discover and well as recover information on a particular subject. Keith Howell spoke for Andrea Lappin who was the Elementary Director for the 2015 Summer School program.

B. North High School Mars Team Presentation

The following North students were selected as the first place team for their Mars research as part of the Mars Exploration Student Data Teams competition, a national program sponsored by NASA and Arizona State University: Joey Bejin, Gabby Feeny, Jamie Lackner, Nate Atkinson, Michelle Bridges and Adam Gellert. In the MESDT program the students participated in training webinars from Mars scientists presenting their questions through an online forum. They were awarded a travel scholarship for winning the competition and last week spent two days at the Johns Hopkins Applied Physics Laboratory in Maryland. The students are members of the North Club, Radio Astronomy Team.

C. Full Circle/Community Campus Report

Sue Banner, Full Circle Director introduced the members of the Full Circle family present: Co-Founders Mary Fodell and Karl Kratz, and Lillie Loder. Mrs. Banner noted that the concept for Full Circle began in 2008 with the intention of creating jobs for students in the community who had aged-out of the district's special needs programs. In 2009 Full Circle opened their first store at Kercheval and Beaconsfield with valuable job training

experience for students. Public awareness and additional opportunities for students were soon created and in April 2010, Full Circle moved to its Kercheval and Lakepointe location. In the fall of 2010, the first Community Campus classroom was developed and a partnership with the Grosse Pointe Public Schools was formed. With increased student independence and access to job skill training as well as other local community businesses, Full Circle Foundation purchased its own building on Mack in Grosse Pointe Park. A second Community Campus classroom opened in January of 2013 and the program became the cutting edge model for public school systems. Enhanced program opportunities were added along with parent awareness in the ability for students to live independently. Full Circle soon added more job skills training; an Upscale Resale Store expansion; an edible garden and outdoor classroom; a laundry program; internet sales and staffing at the Grosse Pointe Shores Park concession stand. The Grosse Pointe Public Schools partner with Full Circle Foundation to maximize the students' opportunities to gain independence, increase soft skills for job training and access community opportunities. Two classrooms for students with disabilities ages 18-26 are being funded by Wayne RESA and in 2014 the Bridges Program was developed to give more special needs students at the high school level additional options. These include programs focusing on transition skills that include academics, community involvment, employability, adult living and vocational opportunities. The team at Full Circle will continue to partner with the Grosse Pointe Public Schools to best meet the needs of this evergrowing population and have already begun to investigate plans for the next 5 years.

D. GPEA Update

Laura Mikesell, GPEA President, said that Full Circle has been a fantastic addition to the Grosse Pointe Public School family. She shared her positive experiences at two Back to Schools Nights. Mrs. Mikesell then noted that she would like to share her speaking time with two other district union presidents.

Kim Van Gorder, President of the GPEASP, thanked Maureen Bur for providing professional development opportunities for her groups' members.

Pat Zens, GPAEOP President also thanked Mrs. Bur for the professional development workshops provided for union members.

Superintendent Niehaus shared information on the Brownell robotics team; the indoor swimming schedule provided to the Board; the progress of the District's Strategic Plan noting that Mrs. Weertz will be the Board member on the core team; September had a great start to the school year; and Mr. Fenton and his team are to be commended for their great job on the registration process of kindergarten students and the verification of 6th and 9th graders.

Superintendent Niehaus said that he was overwhelmed at the standing ovation he received at the all staff breakfast on September 2nd. He also noted that he contracted with Compliance One Security Firm to help the district with security issues and to update the district's emergency operation plans. Dr. Niehaus shared that with that plan, dogs will be training in each school building between now and Thanksgiving.

President Gafa welcomed everyone back to the new school year. She thanked everyone for the respectful, constructive and positive feedback provided in the comments from every speaker. She encouraged the community to stay involved and continue to share their comments and concern. Trustee Gafa congratulated the students from the Mars Team who presented this evening.
