Strategic Plan approved 7-0

Both trustees Gafa and Valente were able to call in for the vote on the Strategic Plan to pass 7-0. Mike Wilmot of Michigan Leadership Institute and cochairs Karl Kratz and Chace Wakefield provided an overview of the process. The full plan and one page summary are posted on our website.

All action items pass unanimously

The Board approved adding a Young Fives program to our kindergarten offerings, with sites at Defer, Mason and Poupard. They also passed the Human Resources report, noting the retirement of our longest serving teacher Deborah Peck and the hiring of Nicole Pilgrim as Human Resources Director. Minutes passed 6-0. Deputy Superintendent Fenton was approved as Homeless Liaison Officer. The first budget amendment, GAAA #1, passed noting the decrease in Act 18 funding, and how fund equity now reflects the 14/15 audit figures and appears on track to meet the 10% target by 16/17.

Action items for the January annual organizational meeting

In January, board officers are elected, board members declare what they will do with their compensation, the 2016 board meeting calendar is set, representatives to MAISL insurance underwriter are appointed, and a resolution is voted upon regarding continuance of funds and designation of signatories on accounts. All board members present stated they would serve in any capacity. Policies clarifying board email use and professional development will also be voted upon.
