# I. CALL TO ORDER

President Gafa called the meeting to order at 7:00 p.m.

#### III. SUPERINTENDENT'S REPORT

#### A. Approval of the renaming of the PAC

Trustee Roeske advised that this is an added agenda item for the Approval of a Resolution in honoring Christian Fenton. After 37 years of employment, Mr. Fenton announced his retirement. Per District policy, the Board may commemorate a District facility to those individuals who have made a significant contribution to the enhancement of education, generally or the District in particular. Mr. Fenton has overseen projects in every building in the district, many that are designated as historic sites. Attached is a Resolution, which would upon approval of the Board, authorize such recognition by rededicating the North High School Performing Arts Center to the Christian A. Fenton Performing Arts Center. This endorsement is approved by every Board Member sitting on this Board.

Trustee Ismail stated that this could not have gone to a more deserving person. Thank you for everything you have done for this school system.

Trustee Roeske mentioned that there was a committee of people who had worked on this, including Mr. Ismail and Roeske, thank you Mr. Fenton.

Trustee Pangborn is also very happy that this has been done. She has worked with Chris for nearly 40 years. Chris is a real person in the community.

#### B. Good News Report from GPEA – Mike Rennell

Mr. Rennell wished Mr. Fenton the best in his retirement and that he will be missed. Mr. Rennell advised the Board that each meeting he will introduce a different group of educators to the Board. This evening South teachers attended and he introduced Kendra Caralis, who has transformed her room to flexible seating for the students. Ms. Caralis has removed the majority of her desks and brought in alternative seating, bean bag chairs, recliners, foot stools and others. Two students spoke about the different environment in the classroom and how much they embraced it.

# C. Discussion of Plante Moran CRESA Contract, proposal for Facilities and Technology Assessment for Prebond Planning

Mr. Paul Wills from Plante Moran CRESA provided information on the services Plante Moran CRESA can provide to school districts. They would help to establish the needs for capital improvement and does a 360 degree view of our facilities. They have worked with many school districts to big businesses. Trustee Roeske confirmed that Plante Moran CRESA will help determine the projects that are needed and how to fund these projects. Trustee Ismail asked several questions of Mr. Wills. Does Plante Moran hire contractors or are they in-house? Mr. Wills says they are in-house contractors. Trustee Summerfield likes the idea of having a plan and with details. He did ask how this is different from what Grosse Pointe Schools has done in the past. Mr. Wills says that this is a 360 degree, not just architectural and alternatives will be provided for financing the projects. President Gafa says this makes sense. Trustee Pangborn is glad that we are talking about facilities. The public needs to know what the costs are to run a school.

First read for information and discussion. An element has been added that is required when working with contractors and is involved with Federal Funds. This brings us in compliance and limits what Board Members can accept as a gift or token.

#### 2. **Deletion of current BOE Policy 1130 Conflict of Interest**

Policy Committee has asked that this be removed and replaced with Policy 8600.

# Creation of a new BOE Policy 8600 Conflict of Interest that would apply to all employees and contractors in GPPSS

This policy encompasses all of the District employees and contractors. This would match up with what we have in the Board By-laws.

#### 4. Revision of BOE Policy 2370 Education Options – Online Learning

Today our policies do not address on-line learning opportunities. This proposal would reflect our new content in this area. Adding in elements on how credit is granted and taking out the programs that are not applicable. Trustee Summerfield says that this is in line with what is required by State law.
