The District is comprised of nine (9) elementary schools, three (3) middle schools, two (2) high schools, an administrative building, and one building which houses preschool and special needs programs

It is the sole responsibility of the bidder to ensure all of their bid documents are uploaded before the closing date and time specified. Bids submitted late or via oral, electronic mail or by facsimile will NOT be accepted. Late bids will not be accepted.

The district reserves the right to accept any item in the proposal; to accept or reject any or all proposals; to waive any informalities herein; or for reasons of establishing uniformity, to award the bid to a company (ies) other than the lowest proposal.

SPECIFICATIONS:

Any deviation from the specifications set forth must be clearly identified and detailed on the bid proposal form; otherwise, it will be considered that items offered are in strict compliance with these specifications, and successful bidder will be held responsible. In the event that a supplier wishes to *bid a voluntary alternate* in addition to the bae bid (and as a cost savings consideration for the District), such alternate shall be submitted with the bid, on a separate sheet and labeled as such with a brief description of the difference and rationale. However, if any substitution or departure is not clearly noted and described, it will be understood that the bid intends to exactly meet the specifications.

SUBMISSION REQUIREMENTS:

All bids must include the following:

- 1. The bid must be signed by an authorized company agent and submitted on the attached forms.
- 2. The signed Iran Economic Sanctions Act.
- 3. The sworn and notarized Familiar Disclosure Statement.
- 4. A Treasury listed bid bond or certified check made payable to Grosse Pointe Public Schools for not less than five percent (5%) of the contract for each bid over \$24,924.
- 5. Completed Vendor profile with references.
- 6. Bid prices must be firm for ninety (90) days subsequent to August 10, 2021.
- 7. Bid prices must include delivery.
- 8. All prices quoted are net and exclusive of all federal, state and municipal sales and excise taxes.
