2021 Technology Cabling

## **BACKGROUND INFORMATION:**

In November 2018, voters passed a bond referendum which would allow the District to begin updating much needed classroom technology. The following information presented to the Board of Education involves structured cabling for buildings in 2021, and continued work from the 2020 buildings.

The project consists of the following (taken verbatim from Plante Moran's attached letter):

- Removing existing structured cabling materials and network closet equipment racks for five (5) district buildings under construction
- Implementing new structured cabling materials for seven (7) district buildings and new network closet equipment racks for five (5) district buildings under construction.

After working with Plante Moran, the District is making the recommendation to award the Cabling Project to the following vendors:

- Active Solutions Group (Maire, Grosse Pointe North): \$313, 336 + \$31,000 (10% Contingency)
- Complete Interactive Technologies (Monteith): \$9,374 + \$1,000 (10% Contingency)
- Learning Consultants, Inc. (Brownell, Richard, Parcells, Grosse Pointe South): \$256.692.48 + \$24,900 (10% Contingency)

The total cost of this project (including contingency): \$636,302.48

This above project is E-Rate eligible, which the District has worked closely with its E-Rate Consultant as part of this project.

**REQUEST:** Board approval of Technology Cabling to Active Solutions Group, Complete Interactive Technologies, and Learning Consultants, Inc. for a total cost of \$636,302.48 on 2/22/2021

### Dear Chris:

This letter transmits an update from Plante Moran (PM) as it relates to the assignment to assist and advise the Grosse Pointe Public School System (GPPSS) in the procurement and implementation of structured cabling systems for the 2021 construction projects (Projects). This update represents the mutual efforts of PM and GPPSS administration (the Project Team) to present a framework in order to identify, evaluate and recommend vendors for the structured cabling projects. This procurement included E-rate eligible services, which allows the District the opportunity to seek federal reimbursement for a percentage of the total project cost. This procurement has followed specific E-rate program guidelines in accordance with the direction provided by the District's E-rate consultant.

The Project Team publicly issued an RFP on the District web site, SIGMA, and the E-Rate Productivity Center for a structured cabling system for seven district buildings. The Project consists of:

- Removing existing structured cabling materials and network closet equipment racks for five (5) district buildings under construction
- Implementing new structured cabling materials for seven (7) district buildings and new network closet equipment racks for five (5) district buildings under construction.

Six (6) bids were received by GPPSS on January 6, 2021 and were opened and read aloud publicly. All six bids received were complete. Bids were evaluated based on five unique evaluation criteria:

- E-Rate eligible costs (30%)
- Compliance to technical specifications (20%)
- Compliance to proposal requirements (15%)
- Ability to support implementation (20%)
- Prior experience (15%)

In accordance with guidance from the District's E-Rate consultant, cost was the most heavily weighted factor in this evaluation. For the remaining four evaluation criteria, weights were assigned based on the importance of that criteria to the District. To disperse the project workload in an attempt to meet the established construction deadlines, the vendor proposals were scored per building for each of the seven buildings in-scope.

The lowest cost vendor for all schools, Capricorn Diversified Systems, did not present adequate prior experience,



having provided no K-12 project references. In addition, the project team has concerns regarding the ability of Capricorn to complete the implementation in accordance with the construction deadlines with limited numbers of project crew members.

While the proposal from AmComm Telecommunications, Inc. received competitive scores based on the E-rate scoring matrix for the 2020 buildings, they would only honor their proposed pricing if awarded half of the project. For this reason, AmComm was not considered in the recommendation.

#### RECOMMENDATION

Based on review of the responses, discussions, and clarifications with multiple vendors, the District is recommending award of this project to the following vendors:

#### **Active Solutions Group**

Active Solutions Group is the recommended vendor for Maire Elementary School and North High School based on the E-rate scoring matrix (see attached analysis). Additionally, Active Solutions Group represents the lowest cost qualified vendor for the scope of work at both buildings. References were all positive.

#### **Complete Interactive Technologies**

Complete Interactive Technologies is the recommended vendor for Monteith Elementary School based on the E-rate scoring matrix (see attached analysis). They have positive prior experience working within the district, as well as significant K12 experience.

### Learning Consultants, Inc.

Learning Consultants, Inc. is the recommended vendor for Brownell Middle School, Richard Elementary School, Parcells Middle School, and South High School based on the E-rate scoring matrix (see attached analysis). They have significant experience in buildings similar to those in the district, as well as significant K12 experience. References were all positive.
