BACKGROUND INFORMATION:

During the 12/21/2020 Board Meeting, the Board of Education approved the purchase of laptops and laptop carts for the District's CTE program (Original Board Memo and Approved Quote attached). After receiving the laptops and the laptop carts, it was determined that a different style laptop cart would be better suited for these particular devices. The original approval for three laptop carts was for a total cost of \$3,087 while the new, better suited laptop carts cost \$3,957, a total difference of \$870.

BACKGROUND INFORMATION:

The Career and Technical Education (CTE) programs generate 61a funding. The district generated \$341,102.55 in 61a funds for the 2020-21 school year. 90% of 61a funding must be spent on program improvement. Brian Stackpoole (North TV Production), Steve Geresy (South TV Production) and Michael Lamb (North Computer Graphics) are requesting the purchase of laptops that meet the higher demand computing needs of their programs. Garrett Kelley (Senior Network Supervisor) and the program advisory board were consulted on the specifications needed for the laptops.

The quote for this equipment has met the requirement of a Cooperative Bid by Dell Computers, and the Laptop Carts is from a Cooperative Bid (REMC) as well.

The District will be able to purchase 96 laptops for \$175,596.48 and 3 carts for \$3,087 using 61a funds for a total of \$178,683.48.
