2021 Project Abatement Contractor Recommendations for Spring Break Work

Dear Ms. Matheson:

This letter transmits an update from Plante Moran Cresa (PMC) as it relates to the assignment to assist and advise the Grosse Pointe Public School System (GPPSS) in the procurement of subcontractor(s) for the Grosse Pointe Public Schools 2021 Abatement Projects (Project) during Spring Break. This update represents the mutual efforts of PMC, NOVA Environmental, Inc. (NOVA) and GPPSS administration (The Project Team) to present a framework in order to identify, evaluate and recommend abatement contractors for the 2021 Spring Break building construction abatement Projects.
