In order that we can all go back to our "paying" jobs. let's just agree to respectfully agree on (after your last email) two points:

1. Your interpretation of the revised OMA and that of the presenter of the seminar I attended whose opinion I share are different; and
2. Based on your last email (below), we have a VERY different interpretation of the duties of the Board Secretary as defined under Policy 171.3. If this definition has been changed over time so that it includes the secretary being the District's defacto website OMA compliance officer, this should be updated immediately and anyone seeking the position of secretary on January 26th should know about this responsibility and its associated liability. If it has been revised to include that responsibility, I would like a copy of the revised Policy 171.3 and would also recommend to the Policy Committee that any involvement by the Board Secretary in interpreting the OMA beyond sharing their opinion as any of us would be removed, as it puts a tremendous burden on the Secretary and unnecessarily relieves the superintendent from the responsibility.

> In an email correspondence from Mrs. Pangborn to Mrs. Kate Murray, GP North Principal, she inquired about three (3) items. In this email, I will respond to the queries presented.

>
> The first item was about the free dental care for all North students donated by the Covenant Community Care program. Mrs Pangborn requested to know how North was contacted and qualified for this extraordinary service.

>
> Last year, Mr. Aaron Johnson had been approached by Covenant Community Care representatives who offered the services to students at GP North HS. Mr. Johnson connected with the GP North counseling staff to coordinate these services for our students.

>
> Covenant Community Care is in partnership with the Michigan Department of Community Health and provides the dental services at no cost for families that do not have dental insurance (see attached flyer).

- > Per a "Good News Item" at a previous GPPSS Board meeting, I informed the School Board that Mobile Dentist was providing free dental care to students at Poupard and over 60 students received dental care and cleanings at that time over a 2 day period.
- >
- > The second item that Mrs. Pangborn presented in her email to Mrs. Murray involved a response back to the [REDACTED] family. Yesterday, I sent to you a summary of the incident and the corresponding response by administration. The GP administrators did correspond with [REDACTED] yesterday and I left a phone message to have the parents get back with me.
- >
- > The third item that Mrs. Pangborn presented was in regard to a video she received from a student about another fight that "looked planned for filming." Mrs. Pangborn sent this video to Mrs. Murray for her review. Upon review, this was a fight that occurred a year ago (January, 2014) with three [REDACTED] students at GP North HS. Given the documented history of disciplinary concerns with 2 of the students involved, the GP administration recommended expulsion for the 2 [REDACTED]. An expulsion hearing took place last year and the guardian and the students did not attend. Both [REDACTED] were expelled from school. The third [REDACTED] received a 10 day suspension from school. This third [REDACTED] is no longer a current student in our school system.

- > In the future, if such behavioral incidents of this magnitude does take place in our schools, I can inform the members of the GPPSS Board of Education. We continue to work to be proactive with our students to reduce and eliminate any conflicts in our school, but when they do occur, our administration thoroughly investigates the situation, follows the student code of conduct procedures, and determines best professional practice and disciplinary actions associated with the factors with the incident.

To the members of the GPPSS Board of Education,

There has been recent discussions about the postings of our School Board meetings and minutes to ensure compliance with the Open Meetings Act. I know that Mr. McInerney, per his recent presentation at the yearly Finance and Law Workshop for School Boards and Central Office, is closely aligned with current updates to the OMA.

About a year ago, we worked with Mr. McInerney to ensure that our posting process was up to date. The following is the correspondence we received from him at that time:

. . . [F]or a rescheduled regular or a special meeting of a public body, a public notice stating the date, time, and place of the meeting shall be posted at least 18 hours before the meeting in a prominent and conspicuous place at both the public body's principal office and, if the public body directly or indirectly maintains an official internet presence that includes monthly or more frequent updates of public meeting agendas or minutes, on a portion of the website that is fully accessible to the public. The public notice on the website shall be included on either the homepage or on a separate webpage dedicated to public notices for nonregularly scheduled public meetings and accessible via a



prominent and conspicuous link on the website's homepage that clearly describes its purpose for public notification of those nonregularly scheduled public meetings. . . .

>

> A durational requirement for posting a public notice of a meeting under this act is the time that the notice is required to be accessible to the public.

>

> The 2012 amendments added the requirement that the posting be in a prominent and conspicuous place and on the website, thus making a posting on an interior bulletin board that is not open to the public (because the building is closed) no longer sufficient

As a follow up to this information, we are extremely careful to make sure that our School Board link on the main page is readily available and can easily link to upcoming Board meetings and Board agendas. We also include on the main page any upcoming Board meetings, times, and locations in the posted calendar of events. We no longer just post the meetings on our bulletin board within 389 but prominently post on the main front and back doors of our Board office building.

With regard to the minutes, Janet Truance puts together the minutes within the required 8 day timeline. They are available for public viewing in our office once completed within that 8 day period with the understanding that they have not been approved by the Board until a formal action has taken place at the next scheduled Board meeting. Once the Board has approved the minutes, we link them to the website under Board agendas and minutes.

If there are any questions regarding this process or concerns, please let me know as we continuously review our compliance to any policies or legal requirements.

> Like many in the Harper Woods community, I am outraged at the recent media coverage aired by Fox TV News (channel 2) of an incident alleged to have occurred at Grosse Pointe High School recently.

> In this coverage, a Grosse Pointe community member, and a person who identifies herself as an individual who substitute teachers in GP schools, "blame" the Harper Woods community and Harper Woods Schools for causing this incident, and it is alleged, others like it.
>
> Responsible media/journalism would not provide a "forum" for the biased and perhaps prejudicial opinions of these individuals. To have done so, was in my opinion, irresponsible journalism.
>
> As a result, the Harper Woods community and HW School are unfairly cast in a negative light. I urge all supporters of the Harper Woods community and it's schools to contact Channel 2 to register your outrage. Their website is: myfoxdetroit.com<http://myfoxdetroit.com>. Simply scroll to the bottom and look at the left corner, you will find the contact information there. All you need to do is click on it..... and register your opinion under the "hall of shame" link.

> Please find the link to the video below. It is not "positive viewing". In my opinion, it perpetuates negative stereotypes and inaccurately "connects" the HW community to this incident, despite no indications in the coverage that the student seen is now, or ever was, associated with the HW community.

> While I am outraged by this media coverage, I also believe it is important to remind ourselves that these negative perceptions came from individuals, not from the Grosse Pointe Communities, nor from Grosse Pointe Schools. In fact, I



was contacted by the Superintendent of Grosse Pointe Schools earlier today, who was equally outraged, and apologetic, that this media coverage unnecessarily "dragged" HW schools into the coverage of this issue. In my tenure as Superintendent, the Grosse Pointe Schools have been "good neighbors" to Harper Woods Schools. I certainly appreciated that the Grosse Pointe Superintendent, Dr. Thomas Harwood, called to express his support for us.

Farmington Public Schools issues survey to gather feedback from parents and community members

Farmington Public Schools periodically issues a formal customer satisfaction survey to receive feedback from parents and community members on how the District is doing. The last time the District issued this survey was in 2011. This year's survey was launched today, January 21, to a random sample of 1,500 residents. Results of the Survey expect to be completed in March and then presented to the Board of Education and shared back with the community.

"These are challenging times, and insight from the community will help strengthen the planning and budget decisions we face," said George Heitsch, superintendent of Farmington Public Schools. "We ask that everyone who receives a survey to please take a few moments to fill it out and send it back."

Those who wish to participate but do not receive a survey can do so by going to www.CobaltCommunityResearch.org/FPS <<http://www.CobaltCommunityResearch.org/FPS%20>> The survey will officially close on Sunday, February 15.

It is important to note that the identity of citizens will not be tied to the results. Confidentiality is an important part of this study.

The study is being conducted by a non-profit program called Cobalt School Engagement and Priority Assessment. It gives local schools solid community-based data to support resource decisions, improve services, measure progress, and build public trust. Because the assessment is a trusted independent assessment, the credibility of the data is solid.

The assessment is powered by the patented technology of the American Customer Satisfaction Index (theACSI.org<<http://theACSI.org>>), the well-respected standard of customer satisfaction metrics for both government and the private sector. The ACSI measures more than two-thirds of the United States economy and produces scores for more than 100 federal government agencies.

This tool is a combined effort of the nonprofit Cobalt Community Research and the CFI Group, who developed the technology behind the ACSI. Cobalt (www.cobaltcommunityresearch.org<<http://www.cobaltcommunityresearch.org>>) is a 501c3 nonprofit organization with a mission to provide research and educational tools that help local governments, schools and other nonprofit organizations thrive as changes emerge in the economic, demographic and social landscape. To the members of the GPPSS Board of Education,

This email to you is in regard to the GP Woods police removal of the student from GP North HS last week due to allegations that he engaged in a breaking and entering into a house of a friend.

First of all, there was no interrogation that took place at the school. The school administrators were informed that the GP Woods police were going to discretely remove him from the school based on these allegations. They requested that the parent not be contacted prior to the removal to decrease the likelihood that the parent would electronically text the student which may result in his being a fugitive in the neighborhood. He is also 18 years old.

After he was removed from the school, the North administration did contact the parent to inform them of the removal from school by the GP Woods police.

Again, please keep in mind that there was no interrogation at the school. Therefore, Board Policy and Administrative Guidelines may not come into place associated with this situation.

However, below is the Administrative Guidelines that exist with Board Policy 5540 - Interrogation of Students.

Taking a Student into Custody

Students shall not be released to law enforcement authorities voluntarily by school officials unless the student has been placed under arrest or unless the parent, guardian, or legal representative (or the student if over eighteen (18)) agrees to the release.

When a student is removed from school for any reason by law enforcement authorities, every reasonable effort will be made to notify the student's parents, guardian, or representative immediately. Such effort shall be documented.

When an attempt to remove a student from school occurs without an arrest warrant or court order or without acquiescence of the parent, guardian, or legal representative, and the student (if over age eighteen (18)), the administrator shall refuse to surrender the student and immediately notify a superior to the law enforcement officers involved to make objection to the removal of the student. An exception to this procedure may be made if the law enforcement officers are properly identified and can convince the principal that there is a probable cause for this action. The Superintendent's office shall be notified immediately of any removal of a student from school by law enforcement officers under any circumstances.

The school principal shall make reasonable efforts to persuade law enforcement officers not to arrest or take students into custody on school premises. Whenever the need arises to arrest or take students into custody on school premises, the principal shall make reasonable efforts to persuade law enforcement officers to use a non-uniformed officer in making the arrest.

When it is necessary to take a student into custody on school premises and time permits, a law enforcement officer shall be requested to notify the school principal and relate the circumstances necessitating such action. When possible, the principal shall have the student summoned to the principal's office where the student may be taken into custody.

When an emergency exists, the principal may summon law enforcement officials to the school to take a student into custody.

When a student has been taken into custody or arrested on school premises without prior notification to the principal, the school staff present shall encourage the law enforcement officers to notify the principal of the circumstances as quickly as possible. If the officers decline to notify the principal, the school staff members present shall immediately notify the principal or the Superintendent. If at all possible, the principal or other school administrator shall notify the parents, guardian, or legal representative of the student before the student is taken into custody by law enforcement officers or as quickly thereafter as possible. The administrator shall document such notification or attempted notification. The Superintendent's office shall be notified immediately of any removal of a student from school by law enforcement officers under any circumstances.

Upon review and discussion with the GP North administration, they followed the process and procedures associated with the Administrative Guidelines. This situation with the GP Woods police and their correspondence with the GP North administration was handled appropriately.

Since the Grosse Pointe School System's website no longer provides the individual school board member's email addresses on the Grosse Pointe Schools website, it is not possible to determine whether or not our correspondence reaches the intended audience. Administrative staff principals – yes; school board members – no. There may be instances citizens wish to address a concern to a particular board member. I suggest the school system set up email accounts for each board member within the gpschool.org website – that way we are not invading the privacy of board members' private email accounts.

As to the incident at Grosse Pointe North and the Administrators' letter of January 15th to the Grosse Pointe North Family, I was disappointed with both. Admittedly, videos don't always tell the whole story, but in this particular case it was compelling. The assault and battery on the student was clearly planned, evidenced by the student who was in place to take the video and the fellow students congregating in the immediate vicinity of the assault. The assault was intentional and not horseplay, for the victim was not a willing participant, and the victim was physically injured.

What might have been tolerated years ago as horseplay or innocent fun gone awry can no longer be tolerated in today's social environment. Student and teacher safety must be paramount. And to fend off spurious claims of injustice by students and parents alike, no unacceptable behavior can be tolerated by anyone at any time. Furthermore, if there is an assault or an assault and battery, the police should be called at once and it should become a criminal matter.

There is a maxim that comes to mind – perception is everything. If citizens perceive an unruly environment in our schools, that's all that matters in the court of public opinion. I hope you get the message.

Please do me a favor and have School ExecConnect forward the items indicated in CAPS to me. I apologize in advance to all for "shouting" by using the CAPS, but I don't think that italics or color will show up if someone has their email set to only receive emails in "text" mode.

I have to say that I am more than disappointed (and frankly a bit disturbed) by the apparent lack of involvement as least this member of the board is being afforded in reviewing the community interface portions of this superintendent search process. My personal opinion, again in all due respect to Dave and Larry, is that the School ExecConnect logo with their mailing address and no phone number is not a good use of ad dollars. Collectively, they are eating up 20% of the ad. More disappointing to me is that these column inches are NOT selling anyone on the virtues of our school system.

Dave made mention in our meeting the other night that the "Grosse Pointe" name alone will attract a lot of interest. That may be true, but name alone isn't going to carry the day on this recruitment, not if we are truly committed to delivery what our community wants. While our school system has a good name nationally, it surely isn't what it was and Michigan certainly isn't the state of choice when it comes to relocating your family.

If you don't believe me, please take the time to think about what the last small ad was that caught your eye. In some way, it was different. That's the ONLY reason you can remember it. Since we aren't going to be the biggest spender on our ads in EdWeek, they need to set us apart and differentiate us in a sea of possibly larger print ads all saying the same thing in virtually the same words in virtually the same type font.

If we don't start taking a "we are different" approach in our marketing our brand and our school system in these ads (as well as in everything else we do), we are going to get the same candidates applying for our position that every other recruiting agent is going to get--those who are looking to step up from being an assistant superintendent at another system, those who are superintendents at very small and very NOT like school systems or those who are ready to or have retired, are fully vested and looking for something to fill their time for a few years. Our community wants none of these, and neither should we.

Even if the deadline has passed for the first insert, there is no reason not to look at it closely for the second insert and EVERY other kind of print or web marketing we do on this project to make sure we project we are a DIFFERENT kind of school system, one that someone who is an innovator would leave a well-paying job to join.

I am willing to help set GPPSS perceptually apart from the masses and know how to do it. If you want my help and are willing to listen, please let me know.

Judy –

- 1) Policy 0166 provides that “Individual Board members may include items on the agenda upon the concurrence of the Board President.” Thus, if you don’t concur, it doesn’t go on the agenda. That implicitly gives you the discretion to condition approval on whatever requirements you want to apply.
- 2) The Open Meetings Act does not require an agenda, so the failure to have an agenda (or to have particular items on the agenda) does not violate OMA. Policy 0166 contains the only requirements governing agendas, and, as discussed above, it gives the President discretion about whether to include something requested by a Board member.

Judy:

I will just share a couple of additional comments for you to use as you see fit.

The data collection process for the search is simply an additional vehicle for persons in the community to be heard who may not be able to attend a focus group meeting. Like the multitude of voluntary online surveys, these do not pretend to be scientific studies of community opinion.

All of the information gained from focus groups and the survey merely informs the Board decisions about the superintendent search profile. The Board ultimately decides what that profile should be, not by survey results or focus group comments but by using their best judgement in conjunction with this information and deciding what the district needs at this point in time.

We will certainly share with you the frequency of responses in each category, but as stated, would not pretend that a voluntary input mechanism of this nature offers a scientific sample of public opinion. These kinds of surveys can be controlled by IP (which we do) or email. Email can suppress participation if participants think their remarks are being tracked, so IP is preferred for this situation. It is certainly true that if someone wanted to spend their time inputting

data on multiple computers they could surely provide multiple entries. For purposes such this (and likely any voluntary online surveys) folks generally feel that the value of collecting the information outweighs the fact that it is not a scientific sample and those who use the information should be well aware of that when making decisions.

A true and precise measure of public opinion would require the employment of a separate survey firm that would develop a statistically accurate random sample, generate voice calls to participants and analyze the results. This would likely cost multiples of your search fee, would be a large endeavor, would not fit into our time frame and was not envisioned in our bid. I know of no other firm that would do this as part of a superintendent search because we will have a very good handle on what our community is thinking by the methods we are using. It is simply not needed.

I suspect you know all of this, but I just thought I would pass along my thoughts.

The following letter will be sent to the Defer families later today with regard to an incident at Defer Elementary.

To the parents of Defer students,

This morning we were informed by a [REDACTED] grade student that when she was on the school playground prior to the start of school, a white middle-aged male wearing jeans and a black North Face jacket engaged her in a brief conversation by asking what her name was, where she lived, if she had any siblings, and did she have a Face Book page. The [REDACTED] grader answered no questions, moved away immediately, and then informed her teacher about the incident. Mrs. Sullivan contacted the Grosse Pointe Park police and an officer met with the student and Mrs. Sullivan this morning to provide information about this interaction.

As we work together as a school community to provide protection and safety for all of our students as they come to and from school, we wanted to provide you with a heightened awareness of this morning's interaction between this student and the unknown adult. This may have been just a brief conversation with no ill will or intent, however, we are always cautious of ensuring that we take all precautions to ensure the safe transitions of our students as they come to and leave school. As many adults walk with their children to school, we would also encourage that our students coordinate a walk to school with a friend whenever possible.

We will continue to monitor this situation and inform you if there is any additional information or updates. The Grosse Pointe Park police intend to be visible at Defer this week both before and after school.
